Global Privacy Policy

PART B – JURISDICTIONAL REQUIREMENTS

For Those in Vietnam

This addendum ("Addendum") applies where the Policy and this Addendum are used for our processing of your personal data pursuant to the Vietnam data protection regulations, including the Government of Vietnam's Decree No. 13/2023/ND-CP on Personal Data Protection dated 17 April 2023, as amended from time to time.

This Addendum supplements the Policy from the perspective of Vietnamese law and is an integral part of the Policy. Unless otherwise specified herein, this Addendum shall prevail over any conflicting provisions of the Policy and amendments thereto (if any). Other sections of the Policy that are not amended hereunder shall remain unchanged.

1. How We Process Your Personal Data

After being collected by us from the relevant sources mentioned in Section 2(a) and 2(b) (How We Collect Your Personal Data) of the Policy and obtaining a necessary legal basis for processing your personal data, we will start processing your personal data in accordance with the Policy and this Addendum. Your personal data will be input by our designated staff of the responsible department into our information technology system and stored electronically and securely on servers operated by us and locked storage. Your personal data will be processed electronically on such servers. We and the parties set forth in Section 4 (Disclosure of Personal Data to Recipients and Joint Use of Personal Data) of the Policy will access, manage, and use the personal data electronically and securely for purposes in accordance with the Policy and this Addendum. If personal data is received directly in the form of paper documents, the hard copy will be kept in a locked document cabinet. The parties set forth in Section 4 (Disclosure of Personal Data to Recipients and Joint Use of Personal Data) of the Policy may download or have us electronically send, store, and use your personal data electronically and securely on servers operated by themselves or third-party vendors for purposes in accordance with the Policy and this Addendum.

2. Potential Unexpected Consequences and Damage that May Occur during the Processing of Your Personal Data

We are committed to the protection of your personal data and have implemented reasonable technical and organizational measures to achieve this goal. However, you acknowledge that no data transmission over the internet is completely secure, and transmissions may be exposed to cyberattacks, resulting in leakage of or unauthorized access to the collected personal data, and that you transmit this data to us at your own risk.

3. Your Additional Rights and Obligations

In addition to the rights listed in Section 6 (Your Rights) of the Policy, you have additional rights granted by the Vietnam data protection regulations, as follows:

- (a) right to consent or not consent to the processing of your personal data, unless otherwise provided by applicable law;
- (b) right to erase, rectify, or review your personal data, unless otherwise provided by applicable law;
- (c) right to complain, denounce, or initiate lawsuits;

- (d) right to claim damages; and
- (e) right to self-defense.

In addition to the rights to your personal data, you have certain obligations, including, but not limited to, the following obligations: (i) to respect and protect others' personal data, (ii) to provide your personal data fully and accurately once you consent to the processing of your personal data, and (iii) to comply with, and to prevent and combat violations of the Vietnam data protection regulations.
